 - I am not a person who is not an employee of the Municipality of Middlesex Centre but who is the Clerk, Treasurer, Integrity Commissioner, Auditor General, Ombudsman or registrar referred to in section 223.11 of the *Municipal Act, 2001* or an investigator referred to in subsection 239.2 (1) of Municipality of Middlesex Centre, or a person who is not an employee of the Municipality of Middlesex Centre but who holds an administrative position of the Municipality of Middlesex Centre.
 - I am not a judge of any court.
 - I am not a member of the Assembly as provided in the *Legislative Assembly Act* or of the Senate or House of Commons of Canada or, if I am such a person, I will provide proof of my resignation in a form satisfactory to the Clerk of the Municipality of Middlesex Centre prior to 2:00 p.m. on Nomination Day, August 19, 2022. I understand that the Clerk of the Municipality of Middlesex Centre will reject my nomination for the above-mentioned office if I fail to provide proof of resignation by this deadline.

6.
