#### Purpose and Effect of the Application


The Municipality is seeking input on a development application within 60 metres of your property. The purpose and effect of the Application for Minor Variance is to seek relief from the Middlesex Centre Comprehensive Zoning By-law 2005-005 as it relates to the maximum permissible gross floor area and height for an accessory building in the Agricultural (A1) Zone. The applicant is requesting a maximum size of all accessory buildings of 185.8 square metres (2000 square feet), whereas the Zoning By-law permits a maximum size of the lesser of one hundred sixty five square metres (165.0 m2) (1776 square feet) of gross floor area or three percent (3%) lot coverage, which in this case would be a maximum permissible size of 165 square metres. The applicant is also requesting a maximum height of 7.77 metres (25' 5  $\frac{1}{2}$ "), whereas the maximum permitted height is 6.5 metres (21.3 feet). The effect of the proposal is to facilitate the construction of one accessory building in the side yard of the property.

#### **Description and Location of the Subject Lands**

The subject property is located on the south east side of County Road 16 (Ilderton Road), west of the intersection at Nairn Road and Ilderton Road. The land is legally described as Part of Lot 10, Concession 8 North, in the Municipality of Middlesex Centre, County of Middlesex and is municipally known as 10651 Ilderton Road.

The public meeting is an opportunity for members of the public to learn more about the proposed development via a brief presentation, ask questions, and/or make statements either in favour of, or in opposition to the proposal. If a person or public body does not make oral submissions at a public meeting or make a written submission(s) to the Municipality of Middlesex Centre before the application is passed, the person or public body is not entitled to appeal the decision of the Council of the Municipality of Middlesex Centre to the Ontario Land Tribunal.

If a person or public body does not make an oral submission(s) at a public meeting, or make written submissions to the Municipality of Middlesex Centre before the application is passed, the

person or public body may not be added as a party to the hearing of an appeal before the Tribunal unless, in the opinion of the Board, there are reasonable grounds to do so.

Notwithstanding the above, subsection 51(48.3) of the Planning Act prescribes the eligible 'persons'

that may appeal the decision to the Ontario Land Tribunal.
