#### **Purpose and Effect of the Application**

The Municipality is seeking input on a development application within 60 metres of your property. The purpose and effect of the Application for Minor Variance is to seek relief from the Middlesex Centre Comprehensive Zoning By-law 2005-005 as it relates to the maximum lot coverage requirements, height and location of an accessory building in the front yard for a proposed accessory structure in the Hamlet Residential First Density (HR1) Zone. The applicant is proposing to construct an accessory building to the side, but in front of the existing dwelling, whereas the by-law does not permit residential accessory structures in the front yard. The applicant is also proposing to construct a building to a maximum size of 142.69 m² (1,535.9 ft²), whereas the by-law permits a maximum size of 60 m² (645 ft²), and a maximum height of 7.6 metres (24.95 feet), whereas they by-law permits a maximum height of 6.0 metres (19.6 feet). The effect of the variance is to permit the construction of an oversized accessory building which encroaches into the front yard.

# **Description and Location of the Subject Lands**

The subject property is located on northeast side of Denfield Road, north of the intersection at Denfield Road and Fifteen Mile Road. The land is legally described as Part of Lot 28, Concession 15 South, in the Municipality of Middlesex Centre, County of Middlesex, and is municipally known as 23830 Denfield Road.

#### Other Information

If a person or public body does not make oral submissions at a public meeting or make a written submission(s) to the Municipality of Middlesex Centre before the application is passed, the person or public body is not entitled to appeal the decision of the Council of the Municipality of Middlesex Centre to the Ontario Land Tribunal.

If a person or public body does not make an oral submission(s) at a public meeting, or make written submissions to the Municipality of Middlesex Centre before the application is passed, the person or public body may not be added as a party to the hearing of an appeal before the Tribunal unless, in the opinion of the Board, there are reasonable grounds to do so.

Notwithstanding the above, subsection 45(12) of the Planning Act prescribes the eligible 'persons' that may appeal the decision to the Ontario Land Tribunal.
