## Purpose and Effect of the Application

The purpose of the application is to seek relief from the Municipality of Middlesex Centre Zoning Bylaw 2005-005 with respect to the exterior side yard setback. The application will facilitate the construction of a single detached dwelling on the subject lands.

#### <u>Information on Appeals</u>

Section 45 (12) of the *Planning Act* identifies who is eligible to appeal the decision of the Committee to the Ontario Land Tribunal. If a person or public body has the ability to appeal the decision of the Committee in respect of the proposed consent to the Ontario Land Tribunal but does not make written submissions to the Committee before it gives or refuses to give a provisional consent, the Tribunal may dismiss the appeal.

## **Other Planning Act Applications:**

B-1-2025 and ZBA-1-2025 – Approved severance and zoning by-law amendment applications that severed the subject land from the dwelling at 92 Harris Road and rezoned them to permit 1 single detached dwelling.
